Board Meeting Notes - February 6, 1977

Present: Zimmerman, Forth, Foster, Ricci, Serbell, Simon, Walsh & Wiggins. Plus Biringer, Kiesling, Kraft and Solow

Advertising: The lack of agreement with Ken Bank was discussed. A motion that his activities at the Independent Press be discontinued was made by Sarah Frth, seconded Walsh and adopted by the Board. Mr Bank to be informed of the decision the following day.

It was decided that any ads brought in by Steve Murray or other unauthorized p persons should be refused. Advertisers affected will be called and advised that the Press will send a representative to take the advertisement if desired. Any money paid by the advertiser to unauthorized persons will be refused by the paper. Advertizers whose ads have been taken by Steve Murray are to be advised thathe is not authorized to represent the paper and the staff was urged to speak plainly to Mr. Murray on any future visits.

Immediate advertising duties are to be assumed by the staff, with Cynthia Rush to be asked to take primary responsibility. S. Forth is to call Antioch College to arrange for internship in advertising on same terms as present interns. Any future advertising hiring is to be done only after candidates have demonstrated ability. A 30 per cent commission on new ads might be offered for two months and straight salary for dealing with old.

Fund Raising: J. Wiggins reported that the joint fund raising effort with Londonderry School will be at the Class I Discoteque on either March 20 or 27. Food and drink plus six hours of entertainment (volunteer) will be offered. Tickets to be sold at \$8.00 per person and \$15. per couple. 450 people to be accommodated/ \$900. in expenses anticipated. Mr. Wiggins will contact Board members for ticket, poster and food chores.

IRS It was agreed that while current telephone excises will be paid, no assistance would be given the IRS in recovering taxes refused during the war years. Ms Forth to check with Bell Telephone Co. for dates taxes not paid.

Barbara Bell, current president of H.I.P., Inc., outlined current financial position. The largest bills include Bell of Pennsylvania, Compugraphics, The Graphic Scene, Peace Center, and Veritas Books. Additionally, Carl Judy has filed a bill for back salary (after the end of the CETA grant) and Gilbert Morrisey has filed a similar claim for back ad commissions. Finally, the Pa. Bureau of Employment Security claims the paper owes it \$500 for back withholding (because of the CETA jobs, the money would then be returned to HIP - who says government doesn't have a sense of humor).

Barbara said the bills from Graphic Scene and Compugraphic are contested. Bell and Foster said that as far as they knew, no decision on salary had ever been made for Carl Judy granting him a continuation of his CETA salary. Additionally, it was said that Gil Morrisey functioned as an outside contractor and would have to present bills, etc, just as any other creditor.

Discussion followed on how best to deal with the debts of the corporation. Tom Schmidt (through Chris Sayer) had suggested that maybe Gil and Carl would assume the liabilities of the corporation since they had taken the assets. There was a consensus that such an approach would not be good since it would not guarantee a "clean" wind-up of the corporation's affairs. The question of filing for bank-ruptcy arose. Barbara Bell said that earlier conversations with Tom Schmidt had indicated that the corporation did not have sufficient liabilities for bankruptcy. Sharon Foster agreed to talk with Tom Schmidt and to set up a meeting with him some afternoon. She will notify people of the agreed upon time.

Also, Barbara Bell said that there is one keg of beer still owed to the paper as a result of an advertising trade agreement. That keg could be used for a fundraising keg party.

There was general agreement that it was important to clear up the debts of the corporation, one way or another, so that the corporation could be maintained and would be in place if people wished to re-start it.

CLEAN UP

It was pointed out that regardless of whether HIP Unit 1 ever restarts, it must be cleaned up. There was a real question of what to do with the waste. It was generally agreed that it was a bad idea to leave the waste on-site.

There are few known repositories of such waste. Serbell had suggested that one shipment be made to the Temple University Library. Kay Pickering said that she has made waste shipments to Swarthmore College Library and that storage facilites exist at that site. Kathy McCaughin said that she had a large amount of containerized waste at her private dumping site. Additionally, it was pointed out that the Pennsylvania State Library has nearly a full set of such waste.

Seriously folks, it was agreed that there was need for a full set of papers to be placed in storage for historical purposes. Priorities was as follows: 1) the State Library, 2) Swarthmore College, 3) the Peace Center.

Kathy McCaughin agreed to catalogue her set of papers.

Hannah Leavitt agreed to contact the state library to see what they have and what they need, and if they are interested in having a full set.

Kay Pickering agreed to contact the Swarthmore Library to determine their interest in having a full set. Swarthmore has a special collection on social change (Kay has sent papers from the Peace Center to their collection).

Chris Sayer agreed to start going through the papers at the HIP office to see what was there.

It was agreed by the group that no papers should be removed until the cataloging effort is complete. No one quite knows how complete a set can be produced.

HIP EMERGENCY MEETING/add two

(Editorial note: It might be possible to ask readers, especially long-time readers, whether they have partial or full sets of papers.)

Office Clean-up: Kathy McCaughin said that she was willing to spend a Saturday going through files, etc upstairs. Chris Sayer said he would also work on that... Saturday, February 28, 1981 was agreed upon as a day to start this work.

MISSING MATERIALS

The following items were taken from the HIP offices by Gil Morrisey and/or Carl Judy:

1. Compugraphic 2 Jr. typesetter

2. Film Processer for the typesetter

3. Fonts for the typesetter

4. Supplies (paper and chemicals) for the typesetter.

5. The phone answering machine

- 6. Light table (metal one from the 3rd floor)
- 7. A chair belonging to Kay or the Peace Center

8. Adding machine

9. The subscriber's file cards

10. The metal subscription plates for the addressing machine.

Initial discussions indicated that people leaned toward some sort of negotiated settlement with Gil and Carl on these items. When it was discovered that they had come into the office and removed the subscribers lists and plates, it was agreed upon that Carl and Gil would be asked to return all items.

No board action had been taken allowing them to remove the materials in question from the premises.

Sharon Foster and Hannah Leavitt called Gil and Carl to ask them to return each item by the end of the week (by Sunday, February 22). Carl Judy said that the material had only been removed to protect it from "creditors." After a long discussion, Carl agreed to return all items (he said the two large items - the light table and the typesetter - might take longer since it would require them to arrange for a truck to transport them).

No decision was made as to further steps to take if the items are not returned.

LOCKS AND KEYS

It was agreed that since Carl and Gil came to the office and removed the subscription lists after they had been made aware (by Bob Becker) of the Sunday meeting, it would be a good idea to change the front door lock. Kay was asked to buy a new lock and make new keys - HIP will pay for the cost.

FINAL MAILING

It was agreed that some sort of final mailing should be done to all the subscribers. No decision was made as to the content or responsibility for the mailing.

It was pointed out that the 2nd class permit expired on January 1, 1981.

It was during this discussion that the removal of the subsciber's list was discovered.

BITS AND PIECES

Barbara Bell said that she thought that HIP's corporate charter had expired December 31, 1980. She said that she had been told that by Carl Judy. Most people present said that they felt that corporation charters did not expire from year to year. Barbara will check with the Pa. Department of State on this matter.

Barbara Bell with check with the Compugraphic lienholder - Chase Manhattan Bank - to see what the current status of the lease is and to determine what papers have been filed for transfer. She said that she had not signed any documents and that any transfer would be invalid without her signature.

The meeting degenerated into "war stories" and a full discussion of why Wiggins would not take McCaughin's \$35 to go to a massage parlor and report on his experiences. So much for investigative reporting.

Further meetings will be held but no date was set for the next meeting.
